Dear Vehicle Donor,

Thank you for considering the donation of your vehicle to the American Lung Association in New Mexico's donation program. Your donation will help us provide services to people with lung disease, help us save lives with our educational programs and will help fund local and national research projects.

In order for your vehicle to qualify for this program, it must be free of any loans or other liens. It does not have to be running, but should be in reasonable condition. You should have a clear title in your name.

The vehicle you donate will be sold "as is" at auction. Our auction partner in this program will handle the towing and sale. After the vehicle is sold, the proceeds are sent to your American Lung Association in New Mexico.


Our donated vehicles are sold at auction. We work hard to secure the highest bid possible; this benefits both you as the donor and the Lung Association's local programs. By selling vehicles at auction, we try to secure a purchase price that is as close to the "fair market value" as possible.

Vehicle donors may take a charitable contribution deduction on their income tax return, to the extent allowed by law for gifts of property to the American Lung Association in New Mexico. We will send you notification of your donated vehicle's gross selling price. The selling price is the value that is tax-deductible. If you believe that your car is worth less than \$500 you may deduct the fair market value up to \$500.

Our vehicle donation program is an excellent opportunity to help the American Lung Association in New Mexico with its activities related to lung health and clean air while providing you with a potential tax deduction for the vehicle's selling price.

## **Donating Your Vehicle is *Quick and Easy!***

1. Sign the Title as "seller" **exactly** as your name is listed on the document (even if you have had a name change). Your Title may also ask you to print your name. Please print your name exactly as your name is listed on the Title.

**NOTE:** If you don't appear as the registered owner on the Title, and the vehicle was reassigned to you, the vehicle must be re-titled in your name as the present owner.

2. Complete the "Statement of Donation" form. Remember to sign and date the form.
3. Print the requested information and sign the "Affidavit of Gift or Motor Vehicle or Boat"
4. Return all of these forms to your American Lung Association in New Mexico.
